RELATIVE CONTRIBUTION OF ACADEMIC INSTITUTIONS TO IBC 2018

The 12th International Business Conference (IBC) was co-organised by North-West University and Milpark Business School from 23 to 27 September 2018 at the Le Meridien Hotel in Mauritius.

A total of 139 (single or co-authored) full proceeding peer-reviewed papers from 20 Southern African and international universities were presented at the conference.

The total author affiliation breakdown for each of the papers are shown on Table 1, and the weighted author contribution for the papers by institution in Table 2.

From the co-organising institutions, NWU and Milpark Business School, the Total weighted author contribution breakdown was 25.66% and 2.52% respectively. A total of 71.82% of the papers were, therefore, from other institutions. This provides sufficient evidence that the DHET 60% rule was met.
